### **FACTS**

#### **WHAT DOES MEROS INVESTMENT MANAGEMENT, LP DO WITH YOUR PERSONAL INFORMATION?**

#### **Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### **What?**

The types of personal information we collect and share depends on the product or service that you have with us. This information can include:

- Social Security number and wire transfer instructions
- account transactions and transaction history
- investment experience and purchase history

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### **How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Meros Investment Management, LP chooses to share; and whether you can limit this sharing.

| <b>For our affiliates' everyday business purposes</b> – <i>sensitive information about your credit worthiness.</i>  | <b>NO</b> , we do not share this type of information with affiliates.  | <b>YES</b> , you can limit sharing information for these purposes.   |
| <b>For our affiliates to market to you</b>  | <b>YES</b> , on occasion, we may share your contact information with an affiliate when we believe you may be interested in affiliated products or services.                                  | <b>YES</b> , you can limit sharing information for these purposes.   |

### What we do:

| <b>How does Meros Investment Management, LP protect my personal information?</b> | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  |
| <b>How does Meros Investment Management, LP collect my personal information?</b> | We collect your personal information, for example, when you <ul style="list-style-type: none"><li>• <i>open an account, complete a subscription agreement or separate account agreement, or deposit money</i></li><li>• <i>direct us to buy securities or direct us to sell your securities</i></li><li>• <i>seek advice about your investments</i></li></ul> We also collect your personal information from others, such as affiliates or non-affiliates. |
| <b>Why can't I limit all sharing?</b>  | Federal law gives you the right to limit only: <ul style="list-style-type: none"><li>• <i>sharing for affiliates' everyday business purposes – information about your creditworthiness.</i></li><li>• <i>affiliates from using your information to market to you.</i></li><li>• <i>sharing for non-affiliates to market to you.</i></li></ul> State laws and individual companies may give you additional rights to limit sharing.                         |

| <b>Affiliates</b>      | Companies related by common ownership or control. They may be financial and non-financial companies. <ul style="list-style-type: none"><li>• <i>Meros Investment Management, LP is affiliated with three (3) investment advisers (Wisdom Fixed Income Management, LLC; Ranger Alternative Management, LP; and Delos Wealth Advisors, LLC), one (1) bank and trust (First United Bank and Trust Company), and one (1) insurance solution provider (Unity Insurance Partners) via common control of First United Bank and Trust. On occasion, your contact information may be shared with affiliates for marketing purposes.</i></li></ul> |
| <b>Non-affiliates</b>  | Companies not related by common ownership or control. They may be financial and non-financial companies. <ul style="list-style-type: none"><li>• <i>Meros Investment Management, LP does not share information with non-affiliates so they can market to you.</i></li></ul>  |
| <b>Joint marketing</b> | A formal agreement between non-affiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"><li>• <i>Certain products and services are offered jointly with third party investment advisors. To the extent information is shared, it will be limited to your contact information.</i></li></ul>  |
